

#### ## REGULATIONS

## \*\*1. Access to the Facility\*\*

Access is allowed upon payment of the entrance ticket or by showing a subscription pass.

Minors may only enter if accompanied by a parent or legal guardian.

#### \*\*2. Documents and Checks\*\*

Customers must present, upon staff request, receipts or passes issued for access.

If needed, ID may be required to use services or prove the age of accompanying minors.

Parents/guardians must closely supervise minors under 14 to prevent harmful behavior.

#### \*\*3. Transfer of Passes\*\*

Passes may not be transferred to others. Doing so results in their withdrawal and loss of related rights.

# \*\*4. Opening Hours\*\*

Open from June 1st to September 16th, subject to changes by the Trieste Harbor Authority.

Opening hours: 8:30 AM to 7:30 PM.

Sea access is allowed from 9:00 AM to 7:00 PM.

Changes will be announced on social media or at the facility.

### \*\*5. May and September\*\*

During May and after September 16th, the facility may open (no swimming) in good weather for sunbathing purposes.

## \*\*6. Temporary Closures\*\*

The facility may close temporarily due to adverse weather (rain, wind, cold, rough sea) or conditions that affect customer or staff safety.

## \*\*7. Customer Behavior\*\*

Clients must behave politely and respectfully toward others and staff. Ball games, loud devices, bicycles, skateboards, spearguns, and harpoons are prohibited.

Crossing barriers and diving in unauthorized areas is not allowed.

#### \*\*8. Animals\*\*

Only guide dogs for the visually impaired are allowed.

Other animals of any kind are not permitted.

## \*\*9. Customer Responsibility\*\*

Clients are responsible for the use of furniture and equipment, and must report malfunctions.

Damages caused by negligence will be charged.

Storing third-party items inside cabins is prohibited.

## \*\*10. Rules for Cabins, Lockers, and Safety Boxes\*\*

Keys must be picked up and returned to the front desk.

A €15.00 fee applies for lost keys (lock replacement).

Gas canisters and hazardous items are not allowed inside cabins.

#### \*\*11. Limitations\*\*

Personal umbrellas are not allowed.

Chairs are available free of charge (one per client); tables can be rented for €2.00 each.

## \*\*12. Areas and Spaces\*\*

Some areas may be reserved for regular use, excluding those with facility-owned umbrellas and loungers.

Management may allocate spaces for associations, researchers, or similar groups.

## \*\*13. Complaints and Suggestions\*\*

Should be submitted in writing or by email to the Management.

## \*\*14. Liability Disclaimer\*\*

The Management is not responsible for: lost or unattended items, or accidents outside the facility's boundaries.

#### \*\*15. General Regulations\*\*

Clients must follow this regulation and comply with the ordinances of the Trieste Harbor Authority.

Failure to comply may result in removal and report to the authorities.
